## 2010 Golf Outing Terms & Conditions

Thank you for considering Valley Country Club as the venue for your golf tournament. We will work closely with you to coordinate all of the elements necessary to ensure a successful and most satisfying outing. ### Deposit & Payments

For all outings reserved in the months of **April and October**, a \$500.00 non-refundable deposit is required with this completed contract to reserve the date.

For all outings reserved in the months of **May and September**, a \$1000.00 non-refundable deposit is required with this completed contract to reserve the date.

For all outings reserved in the months of **June, July and August**, a \$1500.00 non-refundable deposit is required with this completed contract to reserve the date.

The remaining balance due to Valley Country Club under the terms of this contract, to include all Food, Beverage, Golf and Pro Shop charges are due and payable on the day of the outing.

### Cancellation Policy

Once a contract is validated, it is understood that if the client should cancel for any reason before the function is held, the entire deposit is non-refundable, however it is transferable only to another date within the same calendar year.

### Golf Fees

The fee for golf April and October is \$50.00 per player; this includes green fees, cart rentals, and use of the locker room.

The fee for golf May and September is \$70.00 per player; this includes green fees, cart rentals, and use of the locker room.

The fee for golf in June, July, and August is \$80.00 per player; this includes green fees, cart rentals, and use of the locker room.

### Breakfast, Lunch, Dinner, and Beverages

Please see the Golf Outing Menus for your food options and pricing. All menus may be personalized to suit your budget and needs.

**Any outing that wishes to have their own donated beer placed on the course will be charged a \$50.00 fee per location.** Our liquor liability insurance requires Valley Country Club to control all alcoholic beverages.

### Pro-Shop

We respectfully ask that you purchase your prizes and/or gift certificates from our Pro-Shop. Each tournament that purchases a minimum of \$750.00 in pro-shop merchandise, will receive 2 complimentary certificates for foursomes of golf at Valley Country Club.

**General Conditions:**

1. Proper attire is required at all times, **Jeans, short shorts, sloganized tee shirts, tank tops and halter tops are NOT considered suitable golf attire.** Men are required to tuck in their shirts.
2. All final counts of players **and** volunteers must be provided to Valley Country Club no later than 5 days prior to tournament.
3. Suitable attire for the golf course includes: slacks, Bermuda shorts, collared shirts, golf skirts. **Jeans, short shorts, sloganized tee shirts, tank tops and halter tops are NOT considered suitable golf attire.** Men are required to tuck in their shirts.
4. All divots must be replaced and ball marks must be fixed on the greens.
5. Golf carts must follow cart paths at all times, must be kept off tees, and at least 30 feet away from the perimeter of the greens.
