

**VALLEY COUNTRY CLUB 2009 MEMBERSHIPS**  
**OTHER FEES AND CONDITIONS**

1. **Bag Storage Fee** . All Class I, II, III, IV, and V members will be billed an annual Bag Storage Fee of \$100.00.
2. **Handicap Fee** . All golfers will be billed an annual \$25.00 fee, to establish an official handicap.
3. **Cart Fees** . Cart fees for 18 holes are \$18; for 9 holes, \$9.
4. **Cart Minimum** . All memberships will be required to rent the cumulative minimum carts, as stated on Page 1, from April 1st through October 31st. Guest carts will be included. Tournament carts are excluded. Each 9-hole cart rental will count as a 1/2-cart rental. All accounts will be reconciled after the October billing cycle, and those memberships that have failed to meet their minimums will be billed their balances due in their November statements. Cart minimum fees will be pro-rated based on date of entry.
5. **Food Minimum (April-Dec)** . A \$100 food minimum is required for all memberships, except for Junior and Clergy, and except as otherwise stated for Out-of-State Memberships and Business Memberships.
6. **Guest Fees** . Guest fees are \$50, Monday through Friday; \$60, Saturdays, Sundays, and Holidays. Nine-hole guest fees are \$25, Monday through Friday; \$30, Saturdays, Sundays, and Holidays.
7. **Membership Charges** . Each membership will be assigned a number, to be used for all purchases at the club. Credit cards are also accepted for all purchases. Cash purchases are allowed for Pro Shop merchandise.
8. **Billing** . All bills are rendered on the 1st of the month, and are payable in full by the 20th of the month. Bills not paid by the 20th are subject to a finance charge of 1.5% per month. Members who have outstanding bills at the end of a month will be posted. Posted members lose all club privileges until payments have been made.
9. **Voting Rights** . Only Class I and Class II members have voting rights; one vote for each Family, Family I, or Family II Membership.
10. **Upgrading/Downgrading** . Once a membership class has been designated, it may be upgraded, but it may not be downgraded until your next renewal date. An upgrade is subject to Board approval. If a member upgrades to a membership that requires an initiation fee, the fee will be due upon upgrading.
11. **Leaves of Absence** . Members requesting or renewing leaves of absence are required to enroll in Dining Memberships. Members on leaves of absence do not have golf privileges, and are responsible for assessments, if any are levied.
12. **Tournament Play** . Limited to Class I and Class II golfers, if held during their allotted times of play; may be open to other classes, if space is available.
13. **Golf Privileges** . All golfing privileges are subject to outside and in-house tournament schedules.
14. **Social Functions** . All memberships are entitled to participate in all club social functions.
