I understand Valley Country Club is a semi-private country club and I understand:

A.) That upon acceptance of my application, I will be liable immediately for the dues/fees as specified in the Membership Contract Dues and Fees sheet during the Membership Year and subsequent Membership Years, regardless of whether I use the Club facilities for the term or not.

B.) That I must:

- 1) fulfill all financial obligations associated with my membership;
- 2) not to in any way slander or injure the business reputation or goodwill of Valley Country Club in my interactions with other members, prospective members, customers, vendors, competitors, employees of Valley Country Club or on social media.
- 3) Always act in a socially acceptable manner, following all the standards in the Club's policy book, and/or as determined by the Board of Managers, in its sole discretion. Socially acceptable conduct is behavior generally considered appropriate in social settings of mixed company of men, women and children;
- 4) refrain from making any derogatory statements about Valley Country Club, its amenities, its staff or its employees and will refrain from actions that are detrimental, harmful or injurious to the business relationship between Valley Country Club and its members or is not in the best interests of the Club;
- 5) refrain from discouraging members from participating in Club events, functions, tournaments or other activities sponsored by the Club.

Failure to comply with any of the above items will be cause for the Board to impose sanctions, up to and including, suspension or revocation of membership privileges with no refund of the dues.

C.) That in the event my account is in default and is referred to an attorney for collection purposes, **I agree to pay all costs and fees associated with collection, including reasonable attorney's fees.**

D.) That an active, working credit card must always be kept on file, regardless of whether automatic billing is used or not.

E.) That I will receive a member number for charging privileges at the Club. All charges will be billed on the last day of the month and are due and payable on or before the 20th of the following month. If payment is not received by the last day of the following month, a late fee will apply, and all golfing, dining, and other privileges will be suspended as of the last day of the following month.

F.) Unless changed by notice from the Club at the end of a membership year, following the initial Membership Year and upon the expiration of each Membership Year thereafter, **my membership automatically renews for another Membership Year under the proposed Membership Contract Dues and Fees for the new Membership Year, which will be sent to me at least 45 days prior to the commencement of the new Membership Year. I can opt out of the automatic renewal if I notify the Club of my intent not to renew by a written document received by the Club at least 15 days prior to the commencement of the new Membership Year for which I am cancelling my membership in the Club. I will be liable for annual dues and fees as specified in the applicable Membership Contract Fees and Dues for any year in which I am a member whether I used the Club facilities for the full year or not.**

G.) That my initial membership and the automatic renewal thereof for each subsequent year are subject to approval by the Board of Managers.

I understand that false statements made by me or the failure to provide all relevant information may be grounds for denial of my application or for termination of my membership after acceptance. I further understand that if my membership is terminated and there is subsequent inquiry from another private club or social organization, the reason for my termination from Valley Country Club will be disclosed.
